JOHN G. KOELTL, District Judge:

This matter came before the Court on the parties' agreement on the record at trial on October 26, 2009 that judgment be entered in favor of Plaintiff, Barbarian Rugby Wear, Inc. ("Barbarian"), on Count I of its Amended Complaint, and on the parties' agreement on the record on November 6, 2009, that all other claims of the Amended Complaint be dismissed with prejudice, without claims for attorneys' fees or costs. The Court has considered the parties' request and with good cause appearing therefor:

IT IS HEREBY ORDERED that judgment be entered in favor of Plaintiff that

the Plaintiff's use of its trademarks and trade name, namely, BARBARAIN RUGBY WEAR, Registration No. 2,749, 582; and WORLD RUGBY, Registration No. 78/065, 275, and BARBARIAN RUGBY WEAR, INC., do not infringe Defendant's trademarks, or violate any related rights of Defendant.


IT IS FURTHER ORDERED that the remaining claims of Barbarian's Amended Complaint, Counts II-V are **dismissed with prejudice**.

IT IS FURTHER ORDERED that all counterclaims have previously been **dismissed with prejudice**, and there being no further claims the Clerk is directed to enter judgment and to close this case.

Each party is to bear its own costs, and neither party will make any further application for costs or fees.
